 - Any change in location must be approved by the Superintendent of Private Career Colleges (the Superintendent). The Superintendent must be notified at least 30 days in advance in order to arrange for a facility inspection before the college is moved.
- 3. Any additional campuses of the private career college must be registered with the Superintendent
- 4. This Certificate of Registration is not transferable
 - Any change of ownership or change of controlling interest of the college (e.g. asset purchase, share purchase, change of officers/directors, etc...) must be reported to and/or approved by the Superintendent.

 Section 38 of O. Reg. 415/06 requires that the Certificate of Registration be displayed in a conspicuous location where it can be readily observed by students and the public

Private career colleges should be familiar with the requirements of the PCCA. The PCCA and its regulations are available online at <www.e-laws.gov.on.ca>. Please ensure that the email address provided with your registration materials is up to date and checked regularly, as additional communication from the Superintendent will be sent via email.

Private career colleges are required to pay premiums into the Training Completion Assurance Fund (TCAF). You will be receiving an official invoice shortly that will outline the payment requirements. If your premium amount is greater than \$7,500.00, you will be able to pay by instalments (more details will be provided in the invoice).
